1. THE e-PC SYSTEM

The e-PC (Tax Evasion) system is a platform for the public to make complaints about tax evasion against individuals or companies that committing the offense of tax evasion. This initiative is also one of HASiL steps to encourage the involvement of the public in combating tax evasion through a more systematic and rapid distribution of information.

Tax evasion complaints received from the public via e-mail pelariancukai@hasil.gov.my **will no longer apply** and the e-mail removed with implementation of the e-PC system.

The information and identity of the whistle blower is **SECRET** and classified as **CONFIDENTIAL**.

2. BILL NUMBER AS A MANDATORY REFERENCE FOR TAX PAYMENT

The BILL NUMBER will be used as a mandatory reference for the payment of all types of direct taxes start from 1st January 2023 except for the payment of Monthly Tax Deductions (MTD) and Stamp Duty.

Information regarding the BILL NUMBER can be obtained through the following methods:

- i) MyTax Portal at <https://mytax.hasil.gov.my/> > ezHasil Services > e-Billing, or
- ii) Stated in the notice of assessment/estimated and letter of payment demand sent by HASiL to the taxpayer.

Payment can be made online or at HASiL Payment counters and bank agents.

During the transition period of using BILL NUMBER, Tax Identification Number (TIN) or Tax Reference Number still can be use in direct tax payment matters until 30 June 2023.

3. RETURN FORM FILING PROGRAMME FOR THE YEAR 2023

The Return Form Filing Programme for the Year 2023 has been uploaded on the HASiL Official Portal as a reference and guidance for taxpayers to submit their return forms in 2023.

All categories of taxpayers are encouraged to refer to this programme as a guidance to tax reporting process with HASiL .

4. IMPLEMENTATION OF THE USE OF LOCKED BAGS FOR CORRESPONDENCE AND TAXATION NOTICES

All correspondence and taxation notices to HASiL offices in each state will use the Locked Bag address start from 1st January 2023.

This new approach of using only one address to represent all HASiL branch offices in each state is implemented to facilitate customer affairs and ensure systematic tax administration management.
