The following table provides a summary of key amendments to the revised *Guidelines on Sales Practices of Unlisted Capital Market Products* which has been renamed to the *Guidelines on Product Highlights Sheet* (Guidelines) issued on 1 October 2024.

<b>A. Overview</b>			
1. The Guidelines were revised to reflect changes consequent to the issuance of the revised <i>Guidelines on Conduct for Capital Market Intermediaries</i> (Conduct Guidelines) on 1 October 2024. Key amendments include the deletion of Part 2 (Treating Investors Fairly) and Part 4 (Suitability Assessment) as the requirements under these parts have largely been incorporated under the revised Conduct Guidelines.			
2. Housekeeping amendments throughout the Guidelines to provide consistency.
